Superintendent Kane provided the following updates:

- Career Pathways Expo on February 16, 2023 at 6:30 p.m. at Legacy Campus. Parents and students are encouraged to attend to learn more about post-secondary pathways available to students.
- Superintendent Kane attended the District Spelling Bee on February 4, 2023. A total of 72 students participated with 25 finalists moving on to the written round of the state spelling bee on February 23, 2023.
- February 6th-10th is National School Counselor Week. Superintendent Kane expressed gratitude to our school counselors. DCSD has at least one counselor in every school due to the 2018 mill levy override.
- February is Black History Month. DCSD is proud to celebrate our heroes in the African American community and their amazing contributions to history.
- February 15, 2023 is School Resource Officer (SRO) Appreciation Day. Superintendent Kane expressed gratitude for everything our SROs do to keep our schools safe.
- Wish Weeks: Many of our high schools participate in annual fundraisers with Make-A-Wish Foundation to grant a wish to a sick child. Superintendent Kane attended Douglas County High School's Wish Week celebration.
- Incoming 8th Grader Nights are beginning in DCSD high schools.
- Hiring season will kick-off soon. DCSD is striving to post jobs publicly earlier than usual to recruit the best staff.
- On March 4, 2023, DCSD's Legacy Campus is hosting a statewide job fair to recruit teachers. The Colorado Association of School Executives is sponsoring this event.
- DCSD kicked off the equity survey this week which is being conducted by Hanover Research. Superintendent Kane clarified that DCSD is not collecting private information. The "privacy statement" at the beginning of the survey is asking permission to gather survey answers.

Director Hanson moved; Meek seconded the NEW motion that the Board affirm the Superintendent's June 21, 2022 decision in Appeal No. 2022/23-01 that the student be expelled from Douglas County School District through April 27, 2023 because, as hard as this decision was and as much as is at stake for this student, I believe the findings and facts from the initial Hearing Officer and the Superintendent's determination are adequately supported by the record and; therefore, the Board must adopt the Determination of the Appeal and Order of Expulsion affirming the expulsion as presented. The Superintendent should be directed to serve the Determination and Order on the student and the student's parents via hand delivery or email.
