Superintendent Kane provided the following updates:

- DCSD is hosting a job fair at Legacy Campus to recruit licensed staff on the evening of Friday, February 23, 2024. The job fair is open to internal DCSD and external teacher and special education candidates.
- February is Black History Month. DCSD is proud to join our community and the nation in celebrating the history and contributions of African Americans. The theme of Black History Month is "African Americans and the Arts".
- February is also American Heart Month. Today was "Go Red" day for staff at DCSD in support of heart health.
- February is also Career and Technical Education Month. DCSD is incredibly proud of all that we are able to offer our high school students.
- February 5-9 was National Counseling Week. DCSD celebrated its school counselors on DCSD social media channels and on the District's website.
- February 15th is National School Resource Officer (SRO) Appreciation Day. Thank you to all of our current and future SROs with the Douglas County Sheriff's Office, Lone Tree Police Department, Castle Rock Police Department, and the Parker Police Department.
- National Public Schools Week is February 26th through March 1st.
- The Annual Girls and Women in Sports Luncheon is taking place this Friday, February 16th.
- The Douglas County Special Education Advisory Committee is accepting nominations for its Shining Star awards. Shining Stars are DCSD staff members in schools nominated for outstanding service by parents and/or caregivers of students receiving special education services. Nominations will be accepted through February 29th at www.DCSEAC.org.
- DCSD Special Education Directors will host a Coffee Talk on February 21st at 10:00 a.m. in the Wilcox Board Room. Family engagement talks are hosted monthly by the Special Education Department and provide parents and families with relevant information regarding services and supports in the District community. - On February 3rd, students from 57 elementary, middle and charter schools participated in DCSD's annual spelling bee. The top 25 students will move on to the state spelling bee which consists of taking an online test on February 22 with the top 15-20 spellers in the state advancing to the inperson portion of the competition at the University of Denver on March 9th.
- Mountain Ridge Middle School teacher Jennifer Cancino, who has volunteered with the spelling bee for more than 20 years, will retire at the end of this year.
- Twenty-seven students from DCSD's Eagle Academy are making their artistic debut through "Call from the Aerie: An Eagle Academy Art Show", a 2024 Winter Commissioners' Choice Exhibition, at the Lone Tree Arts Center. The free exhibit runs through March 24th.
- On March 8th from 5:30-6:30 p.m. at the Legacy Campus, DCSD is hosting an information meeting about the Accelerating Students through Concurrent Enrollment (ASCENT) Program. This is a fifth-year high school program that allows students to participate in concurrent enrollment the year after 12th grade, enroll in postsecondary courses, and earn college credit at no tuition cost to them or their families.
- CHSAA's Student Leadership Summit will be held this weekend at Douglas County High School. The summit provides students with the opportunity to share projects and program ideas with other Colorado student leaders.

- The CHSAA Girls Swim and Dive State Championships were held last weekend at Castle View High School. DCSD's Mila Nikanorov won the 5A state championship in the 500-yard freestyle in a blazing time of 4:42.49. This is the second fastest time in state meet history and only 0.77 seconds behind Missy Franklin's state record!
- The state wrestling championship is being held this weekend with 36 student athletes vying for the state title.
- Former ThunderRidge High School girls' basketball star Abby Waner Bartolotta was inducted into the CHSAA Hall of Fame. Abby is a legend in Colorado athletics and known as one of the best athletes to ever participate in this state.
- For the first time in school history, three Rock Canyon High School teams took the 5A title championships in boys' cross-country, golf, and POMS.
- Two ThunderRidge High School athletes, Jaxson Remmick and Gavin Hamann, have been awarded scholarships and will play Division I cornhole for Winthrop University in Rock Hill, SC.
- Superintendent Kane and her Cabinet attended and cheered on the Rock Canyon High School Unified Basketball Team at their annual inclusion game.
- Rob Johnson, Athletic Director at Chaparral High School, has been named the 2024 5A Athletic Director of the Year 2024 by the Colorado Athletic Directors Association's (CADA). Mr. Johnson will be officially recognized at the CADA 51st annual awards banquet on April 29th and at a future DCSD Board meeting.
- Wish Weeks are happening across many DCSD high schools and their feeders for the common cause of supporting Make-A-Wish Colorado (or similar organizations) and granting a child their wish.
- This past weekend, Superintendent Kane attended the Elementary School Honor Choir performance and the Middle School Honor Ensemble Concert. Both were incredible.
- Clear Sky Elementary singers were recently selected to sing at the Air Force Academy's men's basketball game.
- Colorado Agriculture in the Classroom (CoAITC) has named Susan Irwin, a
 dedicated STEAM teacher at Pioneer Elementary School in Parker, as the
 recipient of the 2024 Outstanding Teacher Award. Ms. Irwin will be honored
 at a future Board meeting.
- Many DCSD high school seniors participated in the National Letter of Intent Signing Day, committing to being part of a sporting team at the college of their choice. Congratulations to these students and best wishes for their future.

Superintendent Kane and Chief Operations Officer Cosgrove discussed the District's emergency and urgent capital needs and proposed the use of \$20M of the fund balance to address them. This move is necessitated by voters not approving the bond issue that was placed on the November 2023 ballot. Without the passage of a bond, the backlog of deferred maintenance will continue to grow and the risk of infrastructure failures resulting in temporary school closures will increase.

Greg Gotchey, Principal of Chaparral High School, discussed the maintenance needs at his school.

Next steps include requesting Board approval for the proposed use of \$20 million of the fund balance at the February 27, 2024 meeting, polling voters in March and July, and considering placing a bond issue on the November 2024 ballot.

Director Meek and Director Moore will work with staff to develop polling questions.
