Superintendent Kane provided the following updates:

- DCSD hosted the statewide Colorado Education Recruiting Fair at Legacy Campus on March 4, 2023. Approximately 400 job seekers attended and DCSD interviewed over one-third of the candidates.
- April 24, 2023 is a professional development day for licensed staff. Superintendent Kane will present the State of the District and discuss funding challenges at nine separate feeder meetings that day.
- DCSD has engaged a consultant in preparation for potentially placing a bond and mill levy override on the November 2023 ballot. The consultant will assist with polling, focus groups, analysis, ballot language and messaging.
- Thanked the Board members for approving the staff compensation increase at their February 28, 2023 meeting. Superintendent Kane has received positive feedback from staff.
- The Foundation for Douglas County Schools (FDCS) completed its Opportunity Grants cycle and provided approximately \$60,000 in grants to DCSD schools and programs.
- Last week, many DCSD schools participated in Read for Fun events.
- The South Metro Chamber recently visited DCSD's Legacy Campus.
- The Mountain Vista High School boys' basketball team will play in the final four this Friday.
- The state DECA conference was held last weekend and many DCSD students participated.
