On March 8, 2024, Douglas County School District (DCSD) entered into a Letter of Intent for the purchase of an educational facility and grounds located at 10235 Parkglenn Way in Parker for \$4,300,000. The property consists of a 23,950 square foot educational building located adjacent to Highway 83, South Parker Road, between Lincoln Avenue and Plaza Drive. The facility was constructed in 2004 and includes 16 classrooms, offices, over 100 parking spaces with circulation for the pickup and drop off of students, and a basketball play area.

District staff presented the merits of the purchase of this educational facility and grounds to the Board on March 12, 2024 and explained that the property on Parkglenn Way would be ideal to house the Parker Bridge and Child Find programs which need upgraded facilities since the current locations for these programs at 11722 Dransfeldt Road in Parker are substandard for the programs' needs. The Parkglenn Way property could also potentially support additional programs.

The terms of a binding Purchase and Sale Agreement with Seller specify the terms for the District's purchase of the Parkglenn Way property including a purchase/sale price of \$4,300,000; a projected closing date of June 30, 2024; and rights of the District to complete its diligent inspection of the property prior to closing.

District staff recommends that the Board approve the Resolution for the District's acquisition of the 10235 Parkglenn Way, Parker, Colorado property.

Superintendent Kane and Special Counsel Klimesh presented an overview of the Parkglenn Way property as well as next steps and a timeline.

Superintendent Kane and Chief Financial Officer Schleusner discussed the changes being proposed in the state legislature regarding school funding and staff's actions to date to advocate for the needs of Douglas County School District and our students.

The Board considered a draft resolution concerning the financing of Colorado public schools and school districts and discussed and agreed to the following additions:

- Adding the following "Whereas" statement: "WHEREAS, predictable and sustainable funding is crucial for effective long-term planning and investment in our schools; and"
- Adding section 3.e.: "Any changes to the school funding formula takes into account the results of the adequacy study on Colorado school funding scheduled to be completed prior to the 2025 legislative session."
- Adding section 4.: "That the Board and Superintendent actively engage with our local representatives and state officials to ensure a common understanding of the critical need for an equitable, affordable, and sustainable funding formula to support Douglas County students and all Colorado students in our public schools."
