On January 6, 2025, the Douglas County School District (DCSD) Construction Department issued a Request for Qualifications to all 25 DCSD pre-qualified architects to submit proposals to facilitate the Capital Improvement Projects (CIP) as part of the 2024 Bond program. Submittals were received from 15 firms and eight firms were shortlisted and interviewed. Four firms were selected for the CIP projects at neighborhood schools. The interview panel consisted of the Bond Director, Director of Construction, Construction Department staff and Owner's Representatives. These CIP projects are included in the 2024 Bond Plan and 2024 Bond funds will pay for this award.

Next Generation Surfaces LLC submitted a proposal for this project through Sourcewell, a national purchasing cooperative that serves public education organizations, higher education entities, and governments. Per Board Policy DJ, Sourcewell meets all requirements of a formal competitive procurement process to secure the best value to the District. Based on the proposal, a Construction Agreement was issued to Next Generation Surfaces LLC for \$816,900 for the flooring replacement project at Mountain Ridge Middle School. This flooring replacement project is included in the 2024 Bond Plan and 2024 Bond funds will pay for this award.

On October 8, 2024, a Construction Agreement with Crossland Construction Company was issued in the amount of \$456,700 for the second phase of renovations at the Student Support Center. During final inspections with Parker Fire, it was mandated that the fire alarm system be upgraded. This Change Order is for the fire alarm system upgrade.

Also, due to the majority of the window units throughout the building nearing the end of their life cycle and needing to be replaced, this change order is for the replacement of all windows. Replacing all windows at the same time will result in a long-term cost savings due to the economy of scale

The total amount for Change Order 4 is \$209,806.40. With approval of Change Order 4, the total contract cost to Crossland Construction Company will increase to \$1,068,935.17. Change Order 4 and the total contract cost to Crossland Construction Company is within the planned budget for this project.

Superintendent Kane, Chief of Staff Colella, and several cabinet members presented Douglas County School District's plan to address declining enrollment and financial sustainability through strategic school pairings, boundary changes, and transition planning. After extensive community and staff engagement, the district proposed consolidating six elementary schools into three starting in the 2026-2027 school year: Saddle Ranch into Eldorado, Heritage into Summit View, and Acres Green into Fox Creek. Additionally, 6th graders across all feeder systems in Highlands Ranch will transition to middle school. These decisions are supported by logistical, financial, and community-centered criteria, including proximity, building capacity, and educational programming.

The district emphasized community engagement throughout the process, including surveys, public meetings, and individual support for families, especially those with students receiving special education services. Transportation plans, staffing transitions, and programming alignment are central to the implementation strategy. The plan also projects \$30.4-\$42.6 million in savings over five years, allowing reinvestment in student programs and infrastructure. Schools scheduled for closure will remain district assets, available for other educational uses.

Following an extensive question and answer session, the Board of Education voted on the proposed plan.
