The Board discussed the plan forward to complete the Superintendent Performance Evaluation for school year 22-23 in June and the use of rubric derived from Board Policy CBA/CBC, Qualifications/Powers and Responsibilities of Superintendent (Job Description). Board member recommendations included adding sections to the rubric on "Professional Growth and Development", "Policy Governance" and "General Comments"; having the Superintendent provide a self-reflection on the categories in the Superintendent Performance Rubric; renaming the document "Superintendent Summative Evaluation" to align with the Superintendent's contract language; and aligning evaluation scoring with other DCSD staff evaluations. The key requirements in the Settlement and Release Agreement are:

 The Defendants are enjoined from engaging in discussions of public business or taking formal action by three or more members of the Board of Education either as a group or through a series of meetings by less than three members at a time, except in public meetings open to the public. - The Defendants acknowledge that pursuant to the legal advice of counsel, they had non-public discussions among three or more members concerning public business in violation of the Colorado Open Meetings Law.
- The Board will pay \$66,000 to the plaintiff, which are the legal fees he has incurred to date.
