- Benefits open enrollment for employees is taking place through May 19, 2023.

- The annual DCSD Student Art Show was held at Legacy Campus over the past couple of weeks to celebrate K-12 students' artwork. Kendrick loved technology and robotics and he and his parents were immersed in and dedicated to the robotics program at his school. Their mutual dedication resulted in student empowerment and achievement through academic exploration and competition in the field of robotics.
