Elizabeth Hanson announced that she was resigning her position as a School Board Director of District C during a regular meeting of the District's Board of Education held on May 23, 2023 and subsequently submitted a written notice of her resignation

on May 24, 2023. Colorado law provides that a School Board Director's office shall be deemed vacant "[i]f the person who was duly elected or appointed submits a written resignation to the board of education and such resignation has been duly accepted by the board of education..." C.R.S. § 22-31-129(1)(c). A Board Director's written resignation does not create a vacancy in that Director's office until the written resignation has been formally accepted by the Board.

Director Ray recommended that the following language be inserted into the first paragraph: After "WHEREAS, Elizabeth Hanson," add "citing concerns with Board actions on various topics (e.g., politics, racism, equity, termination of former superintendent, and open meeting law litigation),"

NEW - Motion

Director Ray moved; Director Meek seconded the NEW motion to approve the Resolution Accepting Written Resignation of Board Member with the above language insertion.

Friendly amendment: Director Meek suggested the word "her" be added so that the proposed new language reads, "citing her concerns...". Director Ray accepted the friendly amendment.

Upon a roll call vote being taken, the vote was: Aye: 3 Nay: 3. The motion failed 3-3.

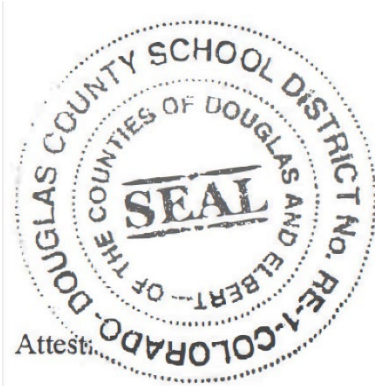
