6. Selection of Director to Fill Board of Education Director District C Vacancy RECOMMENDATION: That the Board of Education take action to fill the vacant Board Position.

President Peterson explained the process by which the Board would select a Director to fill the Director District C vacancy:

a. The presiding officer of the meeting shall call for nominations from the finalists to fill the vacancy. Multiple nominations and seconds may be made. Nominations that receive a second shall then be open for discussion by the

Board. Once discussion is concluded, nominees shall be voted on in order of their nomination by a roll call vote. Once a nominee receives a majority of the votes, that nominee shall be officially declared to fill the vacancy.

- b. In the event of a tie between two remaining nominees, the presiding chair shall call for discussion and voting for up to two additional rounds. If no nominee receives a majority of votes after these two rounds, the matter shall be deemed tabled until the next meeting.
- c. In the event that the Board does not select a person to fill the vacancy by August 5, 2023 (the end of the 60th day following the date the vacancy has occurred), the President of the Board shall appoint a person to fill the vacancy as required by law.

Director Peterson called for nominations to fill the Board vacancy.

Director Williams moved; Director Myers seconded to approve the NEW motion to nominate Jason Page to fill the Director District C vacancy.

NEW - Motion

Director Ray moved; Director Meek seconded to approve the NEW motion to nominate Bradford Geiger to fill the Director District C seat.

Following the above nominations of Jason Page and Bradford Geiger, the Board discussed each candidate's experience and knowledge and how it would benefit Douglas County School District and the Board of Education.

President Peterson conducted a roll call vote beginning with Jason Page's nomination as moved by Director Williams and seconded by Director Myers:
