The Board stressed the need for community engagement and coordinated communication and emphasized the need for all Board Directors to have a clear understanding of the issues and all options available including doing nothing.

Superintendent Kane reiterated DCSD's commitments should school consolidations occur. Chiefly, all staff will have a job and DCSD won't divide communities.
