Lights On Afterschool (DCSD will celebrate its BASE program)

This past Friday was DCSD's first Professional Development Day of the school year. The Legacy Campus hosted a Resource Fair for our elementary school teachers. There were 50 local organizations on-hand providing supplemental resources and programs to support K-6 classroom learning.

Our Safety and Security Team hosted an all-day training for our School Resource Officers and our law enforcement partners facilitated by the FBI in the auditorium at the Legacy Campus. This training is another example of the positive and strong partnerships DCSD has with our law enforcement agencies and partners.

DCSD schools recognized Constitution Day and Citizenship Day on September 17. This day commemorates the September 17, 1787, signing of the United States Constitution. Fun Fact: in 2004, Public Law 108-447 was signed into law, requiring schools receiving federal funds to inform and instruct all students on the importance of the signing of the United States Constitution.

Earlier this week, DCSD hosted its first two feeder meetings to talk factually about how additional Bond funding would impact our schools. Superintendent Kane and school principals talked with staff and families from the Ponderosa and Chaparral feeders. We will continue these meetings with two more taking place on Thursday, September 26 (Mountain Vista and Castle View feeders) and the rest in the coming days and weeks. Thank you so much to our principals for joining these meetings to talk about their schools.

The first Parent University of the school year took place on Wednesday, September 25. The topic is college funding, and the webinar featured guests from the Colorado Department of Higher Education about financial aid options, how to navigate FAFSA and more. Attendees also heard from DCSD panelists who talked about the ASCENT Program.

Next week we are hosting kickoff meetings to embark on the next DCSD strategic plan. We want to hear from our staff, students, families and community members about what DCSD should look like in 2035. The meetings will include a special guest speaker and futurist Dr. Bill Daggett from Successful Practices Network. It's so important for our community to get involved in shaping the future so that our kids can Lead the Way. We want to prepare them for the world and work force that they will experience in adulthood (we know that technology, jobs, etc. is changing very rapidly especially with the evolution of AI). #### 21. State Assessment Data Overview

Learning Services Officer Matt Reynolds presented an overview of Colorado Measures of Academic Success (CMAS) data as well as high school performance data (PSAT and SAT). DCSD CMAS performance data vs State in English Language Arts (ELA) shows DCSD outperforming the state averages. CMAS Math shows the same. Mr. Reynolds gave an overview of trends in ELA and math over the last five years and continues to improve. Participation is impacting data quality (CMAS Science, eighth grade). CMAS Science was reintroduced in Performance Frameworks in 2024. Mr. Reynolds discussed the Colorado High School Assessments: PSAT, NMSQT, and SAT – its scoring and noted that PSAT and SAT were administered online for the first time in 2024, and this impacted scores, specifically in math. The goal of participation is 90-95% and we are currently below that. Graduation competency for SAT: Evidence-Based Reading and Writing, and math.

Student subgroup performance, while improving in many grade levels and subject areas, lags all student performance. The 2024 Preliminary Performance Framework Data shows DCSD at 71.2% which falls in the Accredited category. Noted is that Accredited with Distinction is 74% - 100%. Comparable data vs neighboring districts was shared (showing DCSD over performing LPS, JeffCo, DPS, CCSD, and APS).

Learning Services Officer Matt Reynolds shared the District Accountability Committee's recommendations for the Unified Improvement Plan (UIP). Officer Reynolds covered the District Accountability Committee (DAC) responsibilities: To advise its local school board concerning preparation of, and annually submit to the local school board recommendations regarding the contents of a district plan. In advising and preparing the recommendations, the school district accountability committee shall make reasonable efforts to consult in a substantive manner with the school accountability committees of the school district

Accredited or accredited with distinction - performance plan - school district or institute - contents - adoption. In accordance with times specified in state board rules, each local school board that is accredited or accredited with distinction shall annually adopt a performance plan for the school district. The 2024-2025 timeline was shared: August 15, 2024 - UIP Process Update and Data Release, August 29, 2024 - Preliminary Performance Frameworks Release, August 29, 2024 - UIP Work session, September 19, 2024 - Finalize Recommendations to Board of Education, October 15, 2024 - UIP Plan Submitted for Public Posting on CDE website, and then Spring of 2025, the review released data and updated action steps. Mr. Reynolds explained the plan considerations of goals all entities (BOE, Superintendent, District, CDE). Board of Education goals include Academic Excellence, safe and positive climate and culture, parent/family/community relations and financial well-being. Superintendent goals of academic achievement and growth, positive climate and culture, enrollment and funding opportunities and development of a strategic plan. Major improvement strategies of implementing and aligning instruction to Colorado standards. Alignment of universal and targeted instruction. Implementation of Integrated multi-tiered system of supports for academics, behavior, mental health, health and wellness, and family/community engagement and for improved multilingual learner graduation rates. Action steps for 2024-2025 are to implement core reading programs in elementary schools, continuing focus on evidence-based instruction, targeted work on writing and alignment of ties of instruction with support. Implementation of core reading program in middle schools by providing ongoing support in schools. Professional Learning Communities (PLC) will also be part of action steps to include jobembedded professional development and collaborative leadership training. The staff recommendation is that the Board of Education adopt the 2024-2025 Unified Improvement Plan (UIP) as drafted. Mr. Reynolds noted that the DCSD District Accountability (DAC) recommended that the Board adopt the 2024-2025 Unified Improvement Plan as drafted.
