RESOLUTION OFFICIALLY CERTIFYING THE LEVY OF THE DOUGLAS COUNTY SCHOOL DISTRICT Re. 1 FOR THE  
CALENDAR YEAR BEGINNING JANUARY 1, 2023 TO THE DOUGLAS COUNTY AND ELBERT COUNTY BOARDS OF  
COMMISSIONERS.

WHEREAS, Section 39-5-128(1), C.R.S. requires that Douglas County School District Re. 1 certify its 2022 levy to the Board of County Commissioners of Douglas and Elbert Counties no later than December 15; and

WHEREAS, Section 39-10-114(1)(a)(1)(B), C.R.S. which authorizes school districts to certify an Abatement and Refund Mill Levy in order to recover abatement of taxes.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF EDUCATION, DOUGLAS COUNTY SCHOOL DISTRICT Re. 1:
