

**RESOLUTION OF THE BOARD OF EDUCATION
OF DOUGLAS COUNTY SCHOOL DISTRICT, RE-1**

**Amendment to Plan for Distribution of Additional Mill
Levy Revenue**

WHEREAS, in 2017, the Colorado General Assembly enacted House Bill 17-1375, codified in relevant part at C.R.S. § 22-32-108.5, which provides that, for the 2019-20 budget year and for each budget year thereafter, a local board of education of a participating school district shall either (i) distribute to each charter school of the district 95% of its district per pupil mill levy share multiplied by the number of students enrolled in each charter school, or (ii) implement a plan for equitably distributing its additional mill levy revenue to support all students, regardless of what type of school in which they are enrolled; and

WHEREAS, Douglas County School District, RE-1 (the “District”) authorizes one or more charter schools and, therefore, is a participating school district as defined in C.R.S. § 22-32-108.5(2)(f); and

WHEREAS, pursuant to a resolution adopted on June 5, 2018 in accordance with C.R.S. § 22-32-108.5(4)(a), the Board adopted and implemented a plan that maintained its current level of 100% per pupil mill levy share distribution to District-authorized charter schools (except multi-district online charter schools), and preserved its right to periodically review and update the plan in accordance with C.R.S. § 22-32-108.5(4)(e).

NOW, THEREFORE, BE IT RESOLVED that the Board of Education of the Douglas County School District, Re-1:

THAT, for the 2023-2024 budget year and in each budget year thereafter, the Board shall continue to distribute to each District-authorized charter school of the District (except multi-district online charter schools) an amount equal to 100% of its per pupil mill levy share for the applicable budget year multiplied by the number of funded pupils enrolled in each of such charter schools for the applicable budget year; and

THAT, beginning in the 2023-2024 budget year and in each budget year thereafter, the Board shall distribute to each District-authorized multi-district online charter school an amount equal to 100% of its per pupil mill levy share for the applicable budget year multiplied by the number of funded pupils enrolled in and attending such school’s learning centers that are located inside of the District’s boundaries.

THAT, the Board shall periodically review the plan and update it as necessary to ensure that the additional mill levy revenue that the District collects is equitably distributed as provided in C.R.S. § 22-32-108.5(4)(a) to (4)(c) to the schools of the District to benefit all of the students enrolled in all of the schools located in the District.

APPROVED this 26th day of September, 2023 by a vote of 7 to 0.
