

**RESOLUTION OF THE BOARD OF EDUCATION
OF
DOUGLAS COUNTY SCHOOL DISTRICT RE-1**

NOTICE OF MEETINGS OF THE BOARD OF EDUCATION

WHEREAS, Colorado’s Open Meetings Law, C.R.S. § 24-6-402(2)(c) requires that full and timely notice to the public be given of meetings of the Board of Education; and

WHEREAS, the Open Meetings Law provides that the Board shall be deemed to have given the requisite notice if the notice of the meeting is posted in a designated public place within the boundaries of the School District, which may include electronic posting on the District’s website, no less than twenty-four hours prior to the meeting.

THEREFORE, BE IT RESOLVED, by the Board of Education of the Douglas County School District RE-1 that notice, including specific agenda information where possible, of any meetings of the Board at which the adoption of any proposed policy, position, resolution, rule, regulation, or formal action occurs or at which a majority or quorum of the Board is or is expected to be in attendance, shall be posted no less than twenty-four hours prior to the scheduled meeting on the official website of the Douglas County School District RE-1.; and

BE IT FURTHER RESOLVED, that the posting of such notice on the District’s official website shall be one means of providing full and timely notice to the public of such meetings; and

BE IT FURTHER RESOLVED, that in addition to posting notice on the District’s official website, meeting notices, whenever possible, shall be posted outside the Board Room on the third floor of the School District’s Administrative Offices and on the front door, or proximate to the front door, of the School District Administrative Offices, known as the Wilcox Building, 620 Wilcox Street, Castle Rock, Colorado 80104, visible to the outside; however, such physical posting shall not be deemed to be the official posting location of the Board of Education; and

BE IT FURTHER RESOLVED, that, should the Board be unable to post notice online in exigent or emergency circumstances such as a power outage or an interruption in internet service that prevents the public from accessing the notice online, the Board shall physically post such notice outside the Board Room on the third floor of the School District’s Administrative Offices and on the front door, or proximate to the front door, of the School District Administrative Offices, known as the Wilcox Building, 620 Wilcox Street, Castle Rock, Colorado 80104, visible to the outside; and

BE IT FURTHER RESOLVED, that the online and physical locations for the posting of notice as approved in this Resolution shall continue in effect until changed by subsequent official action by the Board of Education.

ADOPTED and **APPROVED** this 23rd day of January 2024, by a vote of 6-0.
