**WHEREAS**, the Board has duly considered the matter of continued employment for classified at-will employees in the School District.

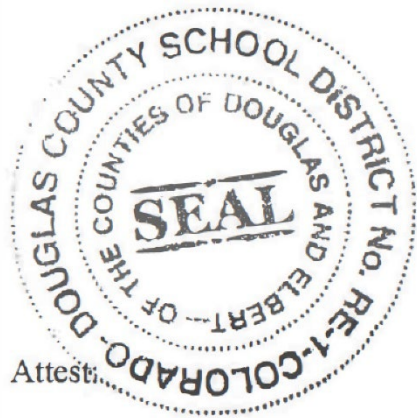
