**RESOLUTION REGARDING THE NON-RENEWAL OF PROBATIONARY
LICENSED EMPLOYEE CONTRACTS**

WHEREAS, the Board of Education of the Douglas County School District RE-1 (“Board”) has received the Superintendent’s recommendation that the contracts of those probationary licensed employees listed on Attachment B to this Resolution not be renewed for the 2023-24 school year; and

WHEREAS, the Board has duly considered the recommendation and the matter of the re-employment of those licensed employees; and

WHEREAS, C.R.S. § 22-63-203(3) requires that by June 1 the Board cause written notice to be provided to probationary teachers that their contracts will not be renewed for the succeeding school year.

NOW, THEREFORE, BE IT RESOLVED by the Board that those probationary licensed employees listed on Attachment B to this Resolution not be re-employed for the 2023-24 school year; and

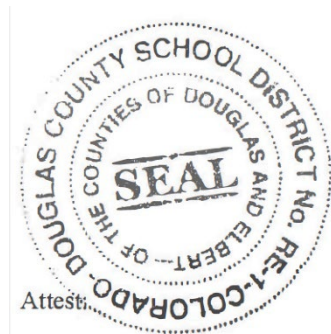
