**NOW, THEREFORE, BE IT RESOLVED** by the Board that the Superintendent or her designee shall be authorized to identify those classified employees whose at-will employment will continue with the School District and to issue to those employees, in accordance with Board action regarding employee compensation, revised at-will employment notices setting forth the applicable rates of pay for work performed after June 30, 2023.
