RENEWAL RECOMMENDATION:

It is the recommendation of DCSD staff that the charter contract between Douglas County School District (DCSD) and DC Montessori School be renewed for a term of 5 years.

RENEWAL APPLICATION PROCESS & EVALUATION:

The renewal process provides an opportunity for schools to (1) present any new or supplemental evidence of school performance and (2) articulate school plans and capacities for the next charter term. The charter renewal recommendation to the Board will be based on an array of evidence gathered over the charter term, including data and information collected by Douglas County School District Office of Choice Programming, the Colorado Department of Education, and any supplemental information that the applicant group provides.

The renewal process begins in September when the charter school declares its intent to apply for renewal. No later than September 1, the charter school submits its Renewal Application to the DCSD Office of Choice Programming. All information is presented to the Superintendent's Cabinet through a compilation of evidence collected through the school's site visit, an analysis of the school's educational, operational, and financial health, and any feedback provided to the DCSD Office of Choice Programming by the applicant team upon initial review of this final report.

SCHOOL OVERVIEW

Mission: The Mission of the DCS Montessori is to provide students with an opportunity to acquire an education based on an authentic and accredited curriculum founded on the educational philosophy of Maria Montessori. **Vision:** DCS Montessori Charter School students enrich the world through positive and substantial contributions in their chosen endeavors.

Key Design Elements:

- Montessori elements kinesthetic modality for all early learning transitioning into more traditional modalities as child development progresses.
- Focused goals are on the "whole child" and long term "successful adult (25 year old)"
- Students' goals are independence, strong work ethic, empathy, and social problem solving skills.

Information Since Last Renewal:

- DC Montessori is now part of the shared SRO pool, providing consistent SRO coverage to the school
- Sources of Strength will continue to Middle School, while also expanding to Elementary grades for SEL
- In 2025, a Roof Solar project will position to school for environmental and financial sustainability
- DCS Montessori Board of Directors participates in annual training to ensure preparedness

A review of the past three years shows that Douglas County Montessori School met many of the fiscal benchmarks set forth by Douglas County School District. Douglas County Montessori School has 11 weeks of reserve fund balance, which has fluctuated over the last 5 years, but always met or exceeded the benchmark.

The school is below the Operating Margin Ratio benchmark for last year. Operating Margin Ratio indicates the amount added to reserves for every \$1 in total general fund gross revenue. Operating Margin has a benchmark of >.01, DCSM has met the benchmark in two of the last three years in 2022 with .03, .02 in 2023 and -.02 for 2024. The school missed the Change in Fund Balance ratio in 2024, this ratio indicates the change in the general fund balance and a consistent decline is not sustainable. Douglas County Montessori School has fluctuated in fund balance over the past five years from .08 in 2021 and 2023 while 2022 was at .13 the current ratio is a -.10 in 2024, the first year of a decrease in fund balance. Douglas County Montessori School shows overall good fiscal health and meets all financial deadlines.

COLORADO LAW - GROUNDS FOR NONRENEWAL

Colorado law (C.R.S. 22-30.5-110) specifies the grounds for revoking or not renewing a charter. A charter may be revoked or not renewed by the chartering local board of education if it determines that the charter school did any of the following:
