And quotes from Poe's poetry, "Quote the Raven Nevermore" are used regularly in current dialogue and our students should be educated to its historical context and origins.
actively engages students through the text	Y	Yes—There is mystery, and sometimes shocking occurrences which captivate the reader. Example: Black Cat is pretty intense for the reader and reading this within an educational environment would allow the students to discuss and learn the symbolism from their teachers.
