Proposed CITE Rubric Changes for 21-22

- Revise the CITE Generalist rubric language and all other related rubrics (i.e., CITE Educator rubric, etc.) to reflect the 2020 Colorado Academic Standards.
 - ◆ Remove 21st century skills and 4Cs language
 - ◆ Replace with Colorado Essential Skills

Colorado Essential Skills

- The Colorado Essential Skills are a required part of the Colorado Academic Standards.
- They are essentially a shift from the 4Cs and 21st century skills to a more comprehensive set of skills.
- The Colorado Essential Skills encompass many of the 4Cs and 21st century skills and add additional skills such as:
 - ◆ Character
 - ◆ Time management
 - ◆ Risk taking
 - ◆ Personal responsibility

Essential Skills (2020 CAS)

Entrepreneurial Skills

- Critical Thinking/Problem Solving
- Creativity/Innovation
- Inquiry/Analysis
- Risk Taking

Personal Skills

- Self-Awareness
- Initiative/Self-Direction
- Personal Responsibility
- Adaptability/Flexibility
- Perseverance/Resiliency

Civic/Interpersonal Skills

- Collaboration/Teamwork
- Communication (using information and communications technologies)
- Global/Cultural Awareness
- Civic Engagement
- Character

Professional Skills

- Task/Time Management
- Career Awareness
- Information Literacy
- Use Information and Communications Technologies
- Self-Advocacy
- Leadership

- Submit updated crosswalks to the Colorado Department of Education and gain approval for use for the 2021-22 school year.
- Introduce the new rubrics to the system at the start of the 2021-2022 school year.
