

Monitoring Report: Executive Limitation

Report Date: April, 2025

Policy E.L. 12 (Student Accommodation) - *The Superintendent shall not make decisions regarding student accommodations that fail to balance fiscal responsibility, adequacy of the learning environment, pedagogical soundness, needs of the district overall and program viability.*

Accordingly, the Superintendent shall not:

- 1. Recommend and/or make changes to student accommodation, which includes school consolidation, significant alterations or additions, boundary changes, or significant grade reconfigurations without first having provided opportunity for input from the staff and relevant Board Committees.*
 - 2. Permit the stakeholders of any school which may be considered for significant modification of accommodations to be uninformed as to the criteria for such a modification and the ability to provide appropriate feedback on that modification.*
 - 3. Permit any deviation from rigorous adherence to written processes that ensure compliance with legislated requirements for the process of determining a modification of student accommodation, or implementing the decision once made.*
 - 4. Permit the Board to be without sufficient information to make fully informed decisions regarding substantial modifications of student accommodations.*
 - 5. Allow use of student accommodations that do not comport with relevant statutes and regulations regarding access for all students.*

Accordingly, the Superintendent shall not:

1. *Recommend and/or make changes to student accommodation, which includes school consolidation, significant alterations or additions, boundary changes, or significant grade reconfigurations without first having provided opportunity for input from the staff and relevant Board Committees.*

Compliance Statement: Compliance will be demonstrated when the Superintendent ensures that changes to student accommodations, including consolidation, alterations, boundary changes, or grade reconfigurations, are only recommended or made after staff and relevant Board Committees are given an opportunity to provide input.

Rationale: Involving staff and Board Committees in the decision-making process fosters transparency, ensures that decisions align with the needs of the school community, and enhances the quality of the decision-making process.

Evidence: Documentation of meetings with staff and Board Committees, meeting minutes, and records showing that feedback was solicited and incorporated where appropriate.

2. *Permit the stakeholders of any school which may be considered for significant modification of accommodations to be uninformed as to the criteria for such a modification and the ability to provide appropriate feedback on that modification.*

Compliance Statement: Compliance will be demonstrated when stakeholders of any school considered for significant accommodation changes are fully informed of the criteria for such modifications and are provided with a clear opportunity to provide feedback.

Rationale: Transparency and stakeholder engagement are essential for maintaining trust in the decision-making process. Providing clear criteria and feedback opportunities allows stakeholders to contribute meaningfully to the process.

Evidence: Communication records (emails, newsletters, etc.) to stakeholders informing them of the criteria, feedback channels, and public meetings or forums held to gather feedback.

3. *Permit any deviation from rigorous adherence to written processes that ensure compliance with legislated requirements for the process of determining a modification of student accommodation, or implementing the decision once made.*

Compliance Statement: Compliance will be demonstrated when the Superintendent ensures strict adherence to written processes that meet legislative requirements for determining and implementing modifications to student accommodation.

Rationale: Adherence to legislated requirements and established processes guarantees that decisions are legally sound, fair, and consistent with public policy, reducing the risk of legal challenges or operational disruptions.

Evidence: Copies of written processes, documentation of adherence to legislative requirements, and any audits or assessments showing compliance with established procedures.

Accordingly, the Superintendent shall not:

4. *Permit the Board to be without sufficient information to make fully informed decisions regarding substantial modifications of student accommodations.*

Compliance Statement: Compliance will be demonstrated when the Board is provided with comprehensive, accurate, and timely information to make fully informed decisions regarding substantial modifications to student accommodations.

Rationale: Providing the Board with sufficient, detailed information ensures that decision-makers can weigh all relevant factors and make decisions that are in the best interest of the district and its students.

Evidence: Board meeting agendas, reports, presentations, and any other documentation provided to the Board members to support their decision-making process regarding modifications to student accommodations.

Accordingly, the Superintendent shall not:

5. *Allow use of student accommodations that do not comport with relevant statutes and regulations regarding access for all students.*

Compliance Statement: Compliance will be demonstrated when the Superintendent ensures that all student accommodations comply with relevant statutes and regulations, including those that ensure access for all students.

Rationale: Ensuring that accommodations comply with legal requirements for accessibility is crucial for providing equal opportunities for all students and protecting the district from potential legal challenges related to discrimination or non-compliance.

Evidence: Audits, compliance reviews, and any correspondence or reports verifying that student accommodations meet relevant accessibility statutes and regulations.
