Superintendent Kane and Chief Human Resources Officer Thompson presented short-term staff retention strategies, made possible through the use of one-time vacancy savings, to the Board which include:

- A \$2,000 PERA-includable retention stipend for regular, full-time positions with an FTE of 0.75 or greater and \$1,000 for regular part-time positions with an FTE less than 0.75 (includes 110 employees) in September 2023,
- A modest ongoing base pay increase with new state revenue (even for those over cell/range and 110 employees),
- Adding one-time monies to Tuition Reimbursement,
- No increase in employee health premiums in 2023-2024,
- One additional personal day added to employees' balance on July 1, 2023.

Long-term retention strategies are under development and will be included in the annual Human Resources update at the February 28, 2023 meeting.
