<u>RENEWAL RECOMMENDATION:</u> It is the recommendation of DCSD staff that the charter contract between Douglas County School District (DCSD) and Ben Franklin Academy be renewed for a term of 5 years.

RENEWAL APPLICATION PROCESS & EVALUATION:

The renewal process provides an opportunity for schools to (1) present any new or supplemental evidence of school performance and (2) articulate school plans and capacities for the next charter term. The charter renewal recommendation to the Board will be based on an array of evidence gathered over the charter term, including data and information collected by Douglas County School District Office of Choice Programming, the Colorado Department of Education, and any supplemental information that the applicant group provides.

The renewal process begins in September when the charter school declares its intent to apply for renewal. No later than September 1, the charter school submits its Renewal Application to the DCSD Office of Choice Programming. All information is presented to the Superintendent's Cabinet through a compilation of evidence collected through the school's site visit, an analysis of the school's educational, operational, and financial health, and any feedback provided to the DCSD Office of Choice Programming by the applicant team upon initial review of this final report.

SCHOOL OVERVIEW

Mission: The Ben Franklin Academy mission is: "To develop young adults with character like America's founding Renaissance man, Benjamin Franklin: well-read, scientifically curious, and civically engaged."

Vision: Our students will excel academically through a challenging, sequenced curriculum that emphasizes math, science, the arts, and literacy. We will be a data-driven institution, focusing on individual students. Our students, teachers, parents, staff, and leaders will be held accountable for the success of our school. Finally, we recognize that an education is incomplete without fostering social emotional development, character, sports, and nature

Key Design Elements:

- Science, Technology, Engineering, Arts, and Mathematics (STEAM) integrated into Core Knowledge Curriculum
- Curriculum evaluation has led to revisions in math K-8 curriculum. Envision Math was adopted in 2022, while Pearson Math is still used for Algebra
- Social Emotional Curriculum is implemented K-8 through Second Step
- All teachers new to BFA are teamed with a team lead for the first year. Mentors are also provided for two years
- Since 2018, full-time School Resource Officer hired, upgraded camera systems, locks upgraded
- Now collaborates with the District, using the Open Enrollment tool, to eliminate the historic waitlist carryover
- Potentially adding a Dean of Students, increasing arts programming, establishing a foreign language program

- No projected increases to enrollment (K-8) in the next 5 years

<u>FINANCIAL ANALYSIS</u> A review of the past three years shows that Ben Franklin Academy met all fiscal benchmarks set forth by Douglas County School District. Ben Franklin Academy has 38 weeks of reserve fund balance, which has steadily increased over the last 5 years. While reviewing the remaining benchmarks, Ben Franklin Academy is well over the required ratio for each fiscal benchmark. Ben Franklin Academy continues to show strong fiscal health and meets all financial deadlines.
