Beyond Extended Learning - Academic Recovery Plans

- Back to School
 - Review and analyze spring data
 - Administer BOY interim assessments
 - Utilize data to identify student strengths and areas of need (State assessments, i-Ready, local measures, ect.)
 - Leverage structures (Professional Learning Communities, Response to Intervention) to address student needs
- Utilize ESSER funds to provide additional supports as needed (tutoring, home visits, credit recovery, etc.)



Academic Recovery Plans

We will continue to offer tutoring services, intervention supports and enrichment opportunities (at no cost to families) throughout the 2021-2022 school year.

Additionally, we are offering social emotional learning supports, literacy supports, family and student re-engagement efforts, and additional evidence based interventions. This is a fluid situation - as we learn more about the academic and social emotional needs of students due to COVID, adjustments may be made to our plan. We will also continue to engage with our families and gather feedback to determine the needs of our students as they return to school this year.

As a district, we continue to assess the academic and social emotional needs of our students and engage with our stakeholders to determine student needs based on the impacts of COVID.
